It is intended that part of that proceeds of the fund will be used to cover eligible payments under the contract for the Tender No: **SMZ/PBZ/KIGA.SC/NCB/2019/MIW/5** for **Construction of Kigamboni and Tandika Service Centre.**
3. The People's Bank of Zanzibar Limited now invites sealed tenders from eligible **"National"** contractors registered as **Building and/or Civil Engineering Contractors** for **Construction of Kigamboni and Tandika Service Centre.**
